"CONFLICT MINERALS" DECLARATION AND POLICY

PATRINI Giacomo Srl supports the fight against violence, the violation of human rights and the environmental damage caused by the extraction and commercialisation of certain minerals or other derivatives (in particular, tin, tantalum, tungsten and gold) in the geographical area defined as the "Conflict Region", which includes the Democratic Republic of Congo (DRC) and the neighbouring countries.

The "Securities and Exchange Commission" (SEC) has established a legislation about the reporting and the publication requirements for "Conflict Minerals", as stated in the "Dodd-Frank Wall Street Reform and Consumer Protection Act" of 2010. The rules require, for manufacturers, to inform if the created products contain metals extracted from the oriental territories of the Democratic Republic of Congo (DRC) and in the neighbouring countries; in this area the extraction of minerals can directly or indirectly finance the violation of human rights or bring benefits to armed groups of these countries.

PATRINI Giacomo Srl does not acquire minerals directly from mines and foundries, but has started to undertake a working process with its suppliers to ensure the non-use of minerals from the region of "Conflict Minerals". Moreover, we commit to not intentionally supply minerals that are from mines in the area defined as "Conflict Region".

PATRINI Giacomo Srl fully supports this law and our position is that of avoiding the use of minerals which are not certified as "conflict free". As declared above, PATRINI Giacomo Srl declares that the used materials for the production of your products DOES NOT CONTAIN minerals ("Conflict Minerals") coming from the following countries:

- Republic of South Sudan
- Central African Republic
- Republic of Congo
- Republic of Uganda
- Republic of Ruanda
- Republic of Burundi
- Republic of Angola
- United Republic of Tanzania
- Republic of Zambia
- Democratic Republic of Congo

In case of variations resulting in the loss of the validity of this declaration, PATRINI Giacomo Srl commits to immediately inform its customers.
